## General Motors ignores Deadly Defect on Seven Models for over a Decade

Engineers at General Motors (GM) discovered an ignition switch defect in 2001. This defect has been linked to at least 12 deaths and 17 injuries dating back to 2005.

Finally, in February 2014, GM recalled over 1.6 million vehicles. The affected vehicles are 2005-2007 Chevrolet Cobalt and Pontiac G5; 2006-2007 HHIR and Pontiac Solstice; 2003-2007 Saturn Ion; 2007 Saturn Sky vehicles; and the 2005-2006 Pursuit sold exclusively in Canada.

The ignition switch is loose which causes it to move from "run" to "accessory" or "off" while the vehicle is driving. Complaints have indicated that the switch can change positions from events as simple as a person's knee can bump a dangling key ring, hitting a bump in the road, trying to tilt the steering wheel, or even the slightest touch of the ignition switch by the driver.

When the ignition switch moves the driver experiences sudden loss of power, including power steering and antilock brakes and airbags are disabled. This means that a driver, without warning, will have to try and control a car that has no power, limited steering and braking abilities, and the threat of being without airbags if a crash occurs. ### Kourtney's Korner "Can my record be cleared?"

Recent changes in the Alabama legislature can provide a way for persons charged, but not convicted, of non-violent felonies or misdemeanors to expunge or essentially erase those charges. Historically, all criminal charges, including dismissals and acquittals, remained on your public record. With the new expungement laws, traffic violations, municipal ordinances, misdemeanors and violations may be erased if the charge was dismissed with prejudice, the person was found not guilty, the charge was


dismissed without prejudice and two years have lapsed or the charge was given a no-bill by the grand jury. Additionally, non-violent felonies may be expunged if the charge was dismissed with prejudice, the person was found not guilty, the charge was given a no-bill by the grand jury, the person successfully completed a diversion program or the five years have lapsed after the charge was dismissed with prejudice. # Upside-down strawberry pie

Pastry for one single crust pie 2 egg whites 1/2 tsp of vanilla 1/4 tsp cream of tarter 3/4 c sugar 3 c fresh strawberries 3 tbsp cornstarch 1 c whipping cream

Line a 9-inch pie plate with crust, flute; bake at 450 degrees for 10-12 minutes. For meringue, beat whites, vanilla and cream of tartar till soft peaks form, add 1/4 c sugar and beat till stiff peaks form. Spread on crust. Bake at 350 degrees for 12 minutes. Mash berries, add water to measure 2 cups. Combine 1/2 c sugar and cornstarch, add berries. Cook and stir over medium heat until bubbly, cook 2 minutes more. Cool, spread over meringue, chill. Spread whipped cream and top with sliced strawberries.



# Testosterone Treatment & Risperdal

Supplemental testosterone medications include: **Axiron**, **Bio-T-Gel, Delatestryl, Forestra, Testim, Androderm, Depo-Testosterone, Striant, Testopel, and Androgel.** 

We are also investigating claims relating to side effects after using **Risperdal**, a drug linked to breast tissue enlargement. **Risperdal** has been associated with an increase in levels of a hormone called prolactin. In females, this can cause glactorrhea, or production of milk. In males, excessive prolactin can cause a condition called gynecomastia.
